A. Snow Removal- Greg Rosholt reported that Steve Britven had a snow plowing contract with St. Philip's that included "right of first refusal" to continue said contract. That right was regrettably overlooked. (a 2011 informal contract was on file at St. Philip's – none from 2012 or 2013)

• Salt and sand parking lot

• Reliable has the ability to clear sidewalks and parking lots at same time utilizing multiple teams of plow operators.

Repairing damage to lawn is built into the contract

• Ability to alter agreement throughout season—ala carte services and a very flexible agreement
