## Financial Report—Greg

It was a good month. We took in \$76,618.

## FYI--Business Manager's Report-Katie

- 1. All the Snowplow Budget for the year has been spent. We will apply for "garage sale" money.
- 2. Endowment funding is for internal betterment. Greg spoke to the Endowment Committee about increasing the distribution rate. Currently, it is at 4%. The rate could increase to 10%. There is a chance that the principle will go down. We wouldn't be able to take out 10% every year. This conversation is just at the idea stage.
- 3. Our boiler is almost 20 years old. It has been leaking water. There is no water on the outside, so it might be the core. The boiler is functioning but is losing water. We don't where the water is going, and we don't know whether the core has a warrantee.

# **Pastor's Report--Pastor Matt**

- 1. Pastoral Acts: Pr. Matt officiated a funeral offsite at Parkway Theatre. Three hundred + people attended, who aren't parishioners.
- 2. Connecting with members: Pr. Matt describes three congregations within St. Philip's: the regulars, the online viewers (50-100 views for every service), and those who attend sometimes in person and sometimes view from home. Pr. Matt wants to visit with the third group to figure out a hybrid ministry.

  - 1. New liturgy. The choir is doing a great job leading the change.
  - 2. Moss/Kurtz fund for new projectors.

  - 5. Our new organist fell and sprained her wrist. We will arrange for substitute organists.
