Although budget of up to \$15,000 was added to BFTFII, trying to keep cost around \$8K or \$9K if possible. Will do most of the installation ourselves, which will save money. A pipe burst in the kitchen 2 weeks ago, but we were able to fix it on our own so there's no plumber cost. Drain backed up in the kitchen, had someone come out to fix but it happened again. The drain seems to be backing up whenever the dishwasher is run, however it also backed up again when the dishwasher wasn't running. The guy is coming back tomorrow to fix and figure out the cause. It's likely caused by water running somewhere in the kitchen. Luckily the water flooding the kitchen floor hasn't reached the new Fellowship Hall carpet. Katie is getting new bids on parking lot lights since the last bid was about 2 years ago. Leak in nursery ceiling by the door A ceiling tile came down, someone is coming to look at it. That part of the roof was replaced in 2015. Patrick Miller did the roof then and will be fixing.

Finances	Greg Preliminary numbers for January 2025 show income of about \$62,000 and expenses about \$65,000, so we ended about -\$3000 for the month.
Business Manager's Report	 Katie Hired cleaning company – They started Thursday and so far it's going well. Reason for hiring: We had previously advertised for a part-time custodian, but nobody applied. Jerry will create a new budget line for the cleaning company. That line item will show a negative in the balance sheet, but it will be offset by the staff salary line item. (The cleaning company will be a contractor. The previous custodians were staff.) The amount we're paying the cleaning company is about the same amount as what we previously budgeted for custodial staff. CD at Trustone – 7-month CD is no longer available. Katie was able to get a 13-month CD at the same rate we were previously quoted for the 7-month CD with Greg's approval. We're doing a new church directory. Pictures will be taken April 24-26. Sign-ups have started for time slots to have pictures taken. Sign-up slots are available online M-F and paper sign-ups are available in the narthex on Sundays.

III.Matt's main portfolio areas

- A. Worship
 - 1. A/V station production phase
 - a) Tom is currently building components

 - a) Lent services will be held in the Fellowship Hall and will use pew chairs for the services

 - 5. It has been working well for choir to sing from the main level of the sanctuary rather than the loft, however movement from pews to get in place to sing has been difficult for some members with mobility challenges.
 - a) A suggested plan to move some pews near the band to have the choir face the congregation so they can sing from where they're seated rather than having to walk up to the front of the sanctuary is being discussed and logistics are being fine-tuned.
 - b) In order to move the choir 3 pews near the band would need to be removed
 - i. Plan to move 2 of these pews to the area near the "pray ground" and the other pew to the left side of the congregation when facing the altar
- B. Stewardship
 - 1. Giving patterns may be shifting
 - 2. Highlight time and talents in the winter and spring
 - 3. BFFII Part of Fellowship Hall remodel is portable staging. We'll order 4 staging sections that are 4'x8' each.
 - a) **Option 1**: Economy Executive from The Stage Depot
 - i. Pros: Cost

- ii. Cons: Everything has to be moved independently. The sections have to be lifted onto a trolley. The stage is not adjustable.
- iii. Warranty: 10 years
- iv. Cost: \$8183.99 Stage w stairs, \$819.90 Guard Rail, \$1379.98 Trolley, \$595.00 Skirting, Grand Total \$10,978.87, shipping not included
- b) Option 2: Executive from The Stage Depot
 - i. Pros: Cost
 - ii. Cons: Everything has to be moved independently. The sections have to be lifted onto a trolley, the stage is not adjustable.
 - iii. Warranty: 10 years
 - iv. Cost: \$9143.99 Stage with 2 sets of stairs, \$819.90 Guard Rails, \$1379.98 Trolley, \$595.00 Skirting, Grand Total \$11,402.87 shipping not included
- c) **Option 3**: Dual Height Executive from The
 - Stage Depot
 - i. Pros: Cost, Dual Height
 - ii. Cons: Everything has to be moved independently. The sections have to be lifted on a trolley. Skirting is not adjustable.
 - iii. Warranty: 10 years
 - iv. Cost: \$9671 Stage with stairs, \$819.90 Guard Rails, \$1379.98 Trolley, 24" Skirting \$700, Grand Total \$12,571.87 shipping not included
- d) Option 4: 1800 Series from Sico
 - Pros: Stage is portable, one person can move it (has wheels and folds up similar to cafeteria tables), Stage has adjustable height 16" & 24", Adjustable guard rails, Skirting is adjustable, a member worked at Sico so we have contacts
 - ii. Cons: Cost
 - Warranty: 3 years against manufacturing defects, lifetime warranty on welds
 - iv. Cost: \$11,894.40 Stage, \$1249.44
 Steps, \$1598.40 adjustable skirting,
 \$1563.84 8' Guard rail, \$1987.20 4'
 Guard rail, Grand Total \$18,433.28
 with shipping
- e) Discussion/items to consider

- i. We have the funds available in the BFTFII account, but do we want to spend that much money?
- ii. The first 3 options would need to be lifted and could be a possible injury risk while the 4th option folds up easily similar to cafeteria tables and is on wheels so it can be moved without a safety risk.
- iii. Most of the time the stage can be left set up, but for some functions where we need more space (i.e. garage sale, larger funerals, some larger events, etc.) the stage sections will need to be moved and stored somewhere.
- iv. We don't have storage space for the stage. We have no idea where we would put the stage if we choose options 1-3. Since the sections for option 4 can be folded up and wheeled somewhere, they could be stored in a hallway or another room temporarily when they can't be in the fellowship hall.
- v. The Wednesday work crew can't help with lifting the stage sections and the 55 & under group isn't always available to help so the first 3 options could be an issue with moving them. We don't always have much advanced notice before a funeral so the 4th option with wheels would better for that aspect because it would allow Katie to be able to move them herself.
- vi. Having an adjustable height option would be ideal and make the staging more useful/versatile since it could be used in different configurations. So in that respect option 3 or 4 would be best.

vii. BOA approved purchase of option 4 as detailed above.

New Business New Mover postcard mailings

- Connie's daughter received a new mover postcard addressed to the previous owner of her house even though she has lived there for several years.
- What is our acceptable margin of error? Should we consider adding "or current resident" to the address?
- Outreach is the company that does the new mover mailings and they also are doing our holiday flyers.
- How they determine who gets the mailer:
 - Change in utilities bill
 - o Subscriptions to magazines and other subscriptions
 - Sale of a house if it is a public record, not all sales are public
 - Time shares Staff actually looks at them individually instead of relying on computer generated information
 - Investment properties Staff actually looks at them individually instead of relying on computer generated information
- These methods are mostly reliable, but nothing is foolproof. This is the first error that we've been made aware of. Outreach has apologized for the error. They have reimbursed us for this error and will do so for any we have in the future.
- Katie will ask if it would cost any extra to add "or current resident" to future mailings.

Mission Corner rule – exception for Girl Scout cookie sales?

- Current policy is to have all sales in the Mission Corner of the Narthex, one group selling per Sunday, and not more than 2 Sundays per month.
- We have 3 girl scout troops that meet at St. Philip's.
- Girl scout cookie sales are February and March 2025, but no slots are available in this timeframe with the current policy.
- BOA approved an exception to the current policy to allow the girl scouts to sell cookies February and March 2025 in either the Mission Corner or Fellowship Hall.

How have we furthered the ministry of St. Philip's?

- We welcomed Dan Eittreim and Mike Youngberg to the Board.
- We approved an exception to the policy regarding selling in the Mission Corner to allow the girl scouts to sell cookies in February & March 2025.
- We accepted Pastor Eric's resignation and wished him well in his new congregation.

- We approved extending the offer to Pastor Sherri Otto for the position of Interim Pastor.
- We decided on staging for the Fellowship Hall and approved "option 4". More details in the BFTF section of Pastor Matt's report to the Board above.
